Eligibility

Participants must be 19 years of age or under and must be enrolled in high school.

Entry Fee

A non-refundable entry fee of \$35.00 must be included, with checks made out to Occuscreen, with 'Sing-Off application' in the memo line. The fee covers all members of the group to all workshops for the morning session.

Audition Recording

Only audio CD's or MP3 files will be accepted and must be postmarked by November 16, 2018.

Your audition recording must be current and be performed only by participants 19 years of age or under, enrolled in high school and eligible to compete on April 13, 2019 under the Rose City Sing-Off Rules. Submissions should include (2) two songs totaling no longer than 12 minutes in length. Recordings must be live, and you may not over-dub or use any form of post-production. CD's should be protected in a proper case and clearly labeled with the group's name, school affiliation, date of recording, and a recording set list.

Rose City Sing-Off Rules

-) Participants must be 19 years of age or under and be enrolled in high school.
-) Each group must submit a completed Application Form, Audition Audio Recording and Entry Fee, postmarked by stated deadline on Application.
-) Each group must submit an audio only recording of (2) two songs totaling no longer than 12 minutes in length, in the form of a CD or MP3 file by the stated deadline on Application. Audition recording must be current and performed only by participants 19 years of age or under, enrolled in high school and eligible to compete on the date of the Rose City Sing-Off.
-) Groups will be considered based on the musical aspects of the Rose City Sing-Off judging criteria and selected by an executive committee.
-) Groups selected to compete in the 2019 Rose City Sing-Off will be notified the week of December 3, 2018.
-) Groups competing in the Rose City Sing-Off will perform (2) two songs totaling no longer than 12 minutes in length. Song choices that are to be performed during the competition must be submitted with the application. Competition song choices do not have to be the same as the audition song choices.
